Re: Expert Witness Testimony

Dear Rev. Bruce & Brenda Shoop

This letter is sent to confirm our conversation over the past weekend and agreement. We agreed that my expert witness testimony to explain the mystery of KNH in the Word should be made available to the State of Alabama. We discussed compensation and documentation regarding the ordination and sanctification to the Office of Bishop that was provided to you both. You asked that an invoice or statement be sent confirming the compensation that this ministry in the Lord considers to be equitable. I explained that the IRS guidelines for travel expense would probably be a good gauge to tabulate the figure.

As you know, my work over the past 6 years has been that of a theologian. My studies of the Writings of Emanuel Swedenborg are exhaustive and complete in that all of those works are mastered. My experiences through the worship practices of the Ethiopian Orthodox religion are an integral part of my work. I was blessed by name, "Greg" through Patriarch Abune Merkorios of the Holy Synod in Exile after receiving the 'nod from God' by the priest who portrayed the Divine Man in holy worship. The website www.heavenlydoctrines.org lists all those theological works and they are available there

for your review. I own a reprint of the large reference or family American Holy Bible printed during the 1870's. This Word was the standard issue of that time in American history. Emanuel Swedenborg and the Swedenborgian religion are documented as a Christian religion and will be made available. During this time of study, I was baptized by order of the General Church of the New Jerusalem. Later, I was given extreme unction through the Coptic Orthodox Divine Liturgy officiated by an ordained priest of that religion as a prophet. Later, I became ordained to the Office of Bishop through Rev. Paul A. Ready the Chaplain for the Veterans for Christ an ordained minister of record in Arkansas with the approval of Rev. Fr. Elmer Heindl the most decorated Chaplain in United States military history. You received documentation to that effect upon your visit here in Atlanta this past weekend.

My doctrinal studies are peer reviewed by Oriental Orthodox Bishops of the Coptic Orthodox Church and Ethiopian Orthodox Church. As well as, Bishops of the General Church of the New Jerusalem (Swedenborgian) along with 40 of their priests that peer reviewed my doctrinal studies. There is no dispute of my findings that KNH in the Word is hemp and this revelation is part of the 'return' of Jesus Anointed the Christian God as part of the Second Coming as documented in the Writings of Emanuel Swedenborg and prophesied in the Word. These doctrinal studies are entitled: Doctrine of Divine Truth; Doctrine of Genuine Truth combating Doctrine of Spurious Falsity; Questions, Concerns, Declarations and Pontifications; Doctrine of Heaven and the Love of Truth; Doctrine of Divine Good and Divine Truth; Doctrine of the revelatory Word in the holy anointing oil of Moses. In these studies, I have examined in depth the literal and spiritual meaning of KNH in the Word from out of the doctrines of the Swedenborgian and Oriental Orthodox Church. The conclusion of these works are accepted and documented by an act of "acquiescence" by Dean Eric Carswell of the Academy of the New Church theological school in Bryn Athyn, Pennsylvania without dispute. Through this work in the Lord Jesus Anointed, I have become the worlds leading expert on KNH in the Word regarding the prophetic nature of this revelation. Your struggle with this radical knowledge of God can be rationally presented through my expert witness testimony.

I tabulated the mileage to and from this office to your office according to these IRS guidelines. @ 48.5 cents per mile x 704 miles = \$341.44 this is adequate compensation.

I reviewed the Alabama decisions on expert witness and the Frye decision still holds for any expert testimony with the exclusion of DNA evidence, which falls under the new federal guidelines. My expert witness testimony meets Alabama guidelines for rules of evidence regarding this specialized understanding of the Word as a minister of the Gospel. I will require advance notification when this testimony is expected. Professional courtesy of 30 days is not out of the ordinary. Your attorney should be notified immediately with this letter and the documentation establishing the Universal Orthodox Church you were given should be copied to his file.
